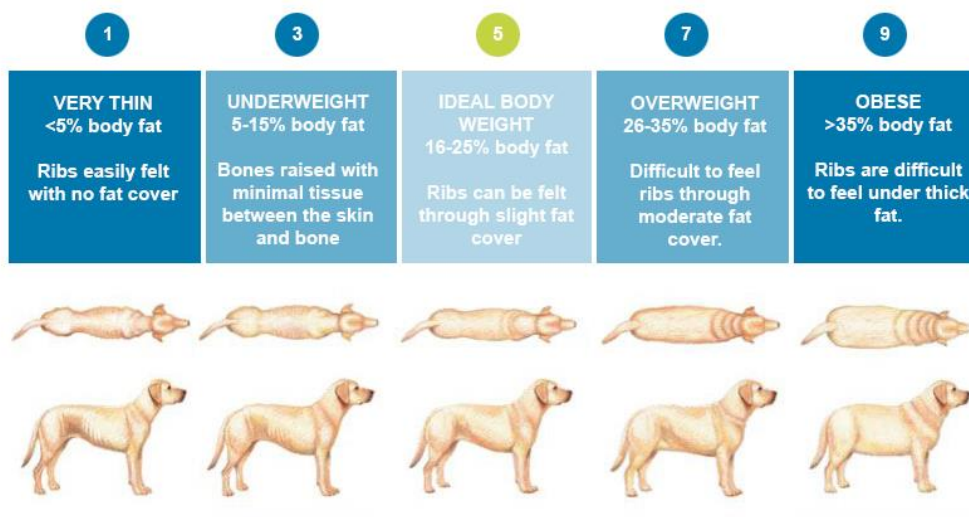

_____	5. Not be spayed or neutered prior to 18 months of age
_____	6. Not be bred or aide in creating any puppies at any time during its lifetime
_____	7. Be fed a species appropriate, high quality diet
_____	8. Have its weight strictly supervised at all times so that it remains at a body condition score of 5 (“ideal”) on the 9 point body condition chart shown below



The Buyer further agrees that they will:

_____	9. Inform Breeder of any change in address or contact details within 10 days of change
_____	10. Provide photos and updates on the puppy/dog in a timely manner when requested by Breeder
_____	11. Contact Breeder as soon as possible in the case of the puppy/dog suffering a serious illness, disease, injury or death
_____	12. Relinquish the puppy/dog to Breeder if the Buyer cannot or no longer wishes to maintain custody of the puppy/dog

Any breach of these terms and conditions could be detrimental to the name and reputation of Breeder and/or the health/welfare of the puppy/dog. As a result, Breeder will be entitled to recoup compensation including but not limited to: solicitor fees, court costs, any and all expenses/damages, value of the puppy/dog, and/or repossession of the puppy/dog as well as any of its non-permitted offspring (if applicable).
